RECOMMENDATION:

Consider a resolution canvassing the City Election held on May 3, 2025 to elect City Council Place 3 and City Council Place 4; declaring the results; and take any necessary action.

BACKGROUND:

On May 3, the City of Grapevine held a General Election to elect City Council Members to Places 3 and 4. Early Voting took place from April 22 – April 29.

There are 39,651 registered voters in the City of Grapevine.

The unofficial results are as follows:

After the Early Voting Ballot Board meets, Tarrant County will provide the official results early next week. At the time, **Resolution No. 2025-006** will be completed and the final results and resolution will be provided to Council at the canvass on May 14.

As a result of votes cast during the May 3, 2025 General Election, Leon Leal is declared duly elected to City Council, Place 3; and Sean Shope is declared duly elected to City Council, Place 4.

The swearing-in ceremony will take place prior to the Regular City Council meeting on May 20, 2025.
